CONTRARY TO NMSA 1978, SECTION 30-6-10.

STATEMENT OF PROBABLE CAUSE

ON SATURDAY, AUGUST 04, 2018, I WAS DISPATCHED TO A HOME LOCATED AT 2412 ELK HORN ROAD, FOR A DOMESTIC DISPUTE.

WHILE IN ROUTE I WAS ADVISED THAT THE FEMALE WHO WAS MAKING THE CALL WAS SITTING IN A CAR IN THE DRIVEWAY. I
ARRIVED ON SCENE AND CONTACTED [REDACTED] WHO WAS SITTING IN A VEHICLE IN THE DRIVEWAY CRYING.

MS. [REDACTED] TOLD ME THAT SHE AND HER BOYFRIEND HAVE BEEN SEPERATED FOR TWO WEEKS BUT SHE HAD BEEN
STAYING AT THE LOCATION WITH THEIR TWO DAUGHTERS WHILE SHE ARRANGED TO MOVE OUT. THIS ARGUMENT HAS BEEN
GOING ON FOR SEVERAL WEEKS AND SHE JUST DOES NOT TRUST HIM. MS. [REDACTED] WAS ATTEMPTING TO LEAVE TO GET
AN APARTMENT.

[REDACTED] TOLD ME THAT SHE HAD BEEN LAYING IN THE BED WITH HER TWO CHILDREN BESIDES HER SEPARATING
HER AND MR. CHACON. SHE FELT SOME MOVEMENT IN THE BED AND THEN FELT MR. CHACON THEN LYING ONTOP OF HER. MS.
[REDACTED] TOLD ME THAT SHE FELT HIM CLIMB OVER HER TWO KIDS TO GET TO HER. MR. CHACON WAS TALKING TO HER ABOUT
GETTING BACK TOGETHER AND INDICATING THAT HE WANTED TO HAVE SEX. MR. CHACON STATED SHE TOLD MR. CHACON NO
AND MR. CHACON THEN BEGAN TO FEEL HER UP AND THEN HE PLACED HIS HAND DOWN HER PANTS AND THEN PLACED HIS
FINGERS INTO HER VAGINA. MS. [REDACTED] STATED SHE CONTINUED TO TELL MR. CHACON NO WHILE TRYING TO GET HIM OFF OF
HER. MR. CHACON THEN ATTEMPTED TO GET HER PANTS OFF WITH FORCE WHILE MS. [REDACTED] SAID NO AND TRIED TO KEEP HER
PANTS ON. MR. CHACON THEN BECAME AGGITATED AND GRABBED HER HANDS AND SHOOK HER HITTING HER HEAD SEVERAL
TIMES CAUSING HER TO HIT HER HEAD ON THE HEADBOARD.

MS. [REDACTED] LEFT THE HOUSE AND WENT TO THE CAR AND SAT THERE UNTIL POLICE ARRIVED.

MS. [REDACTED] WAS TAKEN TO THE HOSPITAL TO BE EVALUATED BY A SANE NURSE WHO OBSERVED DAMAGE TO THE INSIDE OF MS.
[REDACTED] GENITALS.

THE ARREST OF THE ABUSING HOUSEHOLD MEMBER, EDGAR CHACON WAS, IN WHOLE OR IN PART, PREMISED UPON PROBABLE
CAUSE TO BELIEVE THAT THE ABUSING HOUSEHOLD MEMBER COMMITTED DOMESTIC ABUSE AGAINST THE VICTIM [REDACTED]
